John Sullivan, New Hampshire's Revolutionary general and governor, was born February 14, 1740 in Somersworth, N.H. The son of an immigrant Irish schoolmaster, Sullivan studied law with Samuel Livermore of Portsmouth from 1758 to 1760. After practicing a short time in Berwick, Maine, he moved to Durham in 1763 where his success in law and local politics earned him a commission as a major in the N.H. militia in 1772. From September to December, 1774 he served as a delegate to the First Continental Congress. He returned as a delegate in May, 1775 and on June 22, 1775 was commissioned brigadier general in the Continental army.

From July, 1775 until March, 1776 he was garrisoned at Winter Hill outside Boston. With the evacuation of Boston, Sullivan was ordered to the Northern army which was then retreating from Canada. In June, he assumed command of the Northern army but was replaced by Gen. Horatio Gates. With this, he attempted to resign his commission but was dissuaded by John Hancock and in August, 1776 was promoted to major general and assigned to aid in the campaign on Long Island. He was captured August 27, 1776 by the British but later exchanged for Gen. Richard Prescott and spent the winter of 1776-77 in northern New Jersey. In March, 1777, Sullivan returned to New Hampshire to make preparations for the campaign on Staten Island. The winter of 1777-78 was spent with Washington at Valley Forge.

In the spring of 1778, Sullivan was ordered to Rhode Island to assume command of the campaign against the British at Newport. He remained in Rhode Island until March, 1779 when he was ordered to lead a campaign against the Iroquois in western Pennsylvania and New York.<sup>1</sup> Failing health forced him to resign his commission in November, 1779. After this, however, he served as delegate to Congress in 1780-81; as attorney general of New Hampshire, 1782-86; as governor (president) of New Hampshire, 1786-87, and again in 1789; and as U.S. district judge of N.H. from 1789 to his death in 1795.<sup>2</sup>

The Papers consist mainly of correspondence for the years 1769-1792 but are heavily weighted to the years 1775 to 1779, the years Sullivan served in the Continental army. Within these years, the bulk of correspondence pertains to the Rhode Island campaign. The majority of the papers are printed in Otis G. Hammond, ed., The Letters and Papers of Major General John Sullivan, 3 vols. NHHS, Collections XIII-XV (1930-1939); NHHS Lib. Call No., 997.8/N5321c.

The subject matter of the correspondence is largely military: strategy, planning, supply, orders, troop strengths. There is some political comment, principally in the correspondence for the years 1780-1792.
