This collection is mainly a genealogy of the Baldwin family and the Church family. Family correspondence, letters, a scrapbook, newspaper clippings, drawings, and more are included.

Collection Overview

Biographical Information:

Henry Erastus Baldwin was born on December 19, 1815 at Newport, NH, son of Erastus and Lucy (Church) Baldwin. For several years, he was the editor of the *Argus* newspaper. He also served in the legislature and was the private secretary to President Franklin Pierce. He was a designer and engraver. At Newport on March 10, 1848, he married Marcia L. Gilmore, who was born at Newport on June 15, 1828, the daughter of Thomas W. and Hannah B. (Lovejoy) Gilmore. She died there on July 8, 1849. Henry died on February 12, 1857 at Washington, DC.

Samuel C. Baldwin was born on September 15, 1817 at Newport. He worked with his brother Henry on the *Argus* newspaper. He moved to Massachusetts and worked on the *Plymouth Rock* newspaper. He also served in the legislature. When he returned to New Hampshire, he settled in Meredith and was the editor and proprietor of the *New Hampshire Democrat*. He married Sarah S. Hatch at Newport on June 16, 1842. Sarah was born at Hillsborough, NH, on June 19, 1824,

the daughter of Mason and Apphia (Andrews) Hatch. Samuel died at Laconia on December 3, 1861. Sarah died at Newport on February 24, 1913.

Collection Scope and Content Note:

The Baldwin and Church Family Papers, 1780-1934, consist largely of genealogical records for both families. The collection also contains family correspondence, a deconstructed scrapbook, and reminiscences of Henry E. Baldwin who served as secretary to Franklin Pierce. Also included are newspaper clippings, drawings of houses, a broadside of the Newport Dramatic Club, and a printed issue of *Mother's Magazine*. Family genealogy includes dates of ancestors such as Samuel Church, the marriage of Samuel C. and Sarah Symonds Hatch, a family register, bond to Micah Flanders, and other family genealogy and correspondence.

The family correspondence includes an account of Captain Samuel Church of Wilcox & Church, a receipt to the town for school, a signed letter from Franklin Pierce recommending S. C. Baldwin as a Navy purser, a letter from C. G. Atherton recommending H. E. Baldwin as a Navy purser, six letters by Henry E. Baldwin while Secretary to Franklin Pierce in 1854-1856, and two letters from French children to an unnamed American benefactor.

A deconstructed scrapbook contains a variety of materials including genealogy, Samuel Church appointment as coroner, deeds, guardianship papers, letters of William W. Stark, and appointments of Samuel Baldwin to the New Hampshire Militia, Court of Common Pleas, and Supreme Judicial Court. The Reminisces of Henry E. Baldwin contains information on the militia, church music, maps of Newport, town anecdotes, and notes on his activities, such as working for a printer, teaching school, etc. Also included in the collection is a manuscript volume called "A simple diary of everyday thoughts and events...", dated 1846 to 1850 (with gaps), covering activities and people in Boston, when he worked in the Customs House, courting Marcia, visiting Concord to see Franklin Pierce, philosophical musings, marriage to Marcia, long critical illness of Marcia, and her death.

The newspaper clippings detail the early history of Newport and the drawings of houses include sketches of where three family members were born, and an unidentified mansion.
