Abstract:

Charles H. Burns (1835-1909) was a lawyer who lived in Wilton, NH, and practiced there and in Nashua, NH. He served as U.S. District Attorney for New Hampshire from 1881 to 1877 and was active in Republican politics, presiding at the Republican State Convention in 1878. He had some local renown as an orator. He married Sarah Mills of Milford, NH, in 1856; they had 8 children, four of whom survived him. His papers consist primarily of his diaries, kept between 1855 and 1908. In addition, there are notes on and accounts of some of his legal cases, financial records, scrapbooks, and photograph albums.

Scrapbook 1 consisted of newspaper clippings pasted into a printed volume "Annual Report of the Attorney-General of the United States," which was heavily water damaged and moldy. Pages with clippings were photocopied and the book discarded. These photocopies are found in Box 5, folder 5.

Collection Overview

Biographical Information

Charles H. Burns was born in Milford, New Hampshire, on January 19, 1835 to Charles A. Burns (1809-1857) and Elizabeth (Hutchinson) Burns (1816-1885). His father, Charles A. Burns, was an early and active abolitionist; later commentators thought Charles H. Burns' commitment to the Republican Party was in part because of his early exposure to those sentiments. He was educated at Appleton Academy and after graduating in 1854, taught school for four years. He then attended Harvard Law School, graduating in 1858; he immediately began to practice law in Wilton, New Hampshire. Eventually, he was busy enough to open an office in Nashua, New Hampshire. According to the New Hampshire Bar Association's remembrance of him, he practiced general law, including representing both defendants and plaintiffs in several murder

cases. He was the U.S. District Attorney for New Hampshire from 1881 to 1887 and a member of the New Hampshire State Senate in 1873 and 1879, when he chaired the Judiciary Committee.

Burns had a reputation as a gifted orator and public speaker, attributes his fellow attorneys thought contributed to his success in presenting cases to juries. He used those skills to campaign for Republican candidates throughout the state and was an influential member of the party, serving on numerous committees. He presided at the New Hampshire Republican Convention in 1878.

He married Sarah Mills of Milford, NH, on January 19, 1856. She was born at Milford on December 15, 1835, the daughter of John and Sarah P. (Putnam) Mills. Charles and Sarah had eight children (only seven are identified), four of whom were still living at his death: Arthur H., 1856-1876 Sarah E., born 6 July 1859, married William A. Gregg, died November 9, 1953 Bessie, born 1860 Mary Belle, 1861-1863 Charles Alonzo, born January 3, 1863, married Arabelle Grace (Chappelle) Gillis, died December 31, 1930 Blanche May, born May 5, 1868, died April 28, 1960 Benjamin Emery born July 21, 1872, married Lenore R. Wingate, died April 14, 1936

Charles H. Burns died May 22, 1909 and Sarah died April 14, 1915, both at Wilton.

Scope and Content Note:

The Charles H. Burns Papers consists of his largely undated commonplace books (bound notebooks into which he copied excerpts from things he read, facts he wanted to remember, etc.), diaries with cash expenditures listed, kept from 1855-1857 and 1879 to 1908, scrapbooks of mostly undated newspaper clippings about political campaigns, and undated and unidentified photographs, including some of Camp Algonquin. There are three photograph albums consisting of cabinet cards and carte de visite, of which most of the images are unidentified. His legal career is documented by notes on cases, New Hampshire Supreme Court dockets, and printed proceedings of one or two cases involving railroads. A volume of conveyances includes an annotated list, plot plans, and blueprints – some tipped in and others loose. There are printed copies of two of his speeches, a printed eulogy, and a copy of the New Hampshire Bar Association's "Memoir of Charles H. Burns."

There is also some miscellaneous material: checkbooks belonging to James Gregg and a few photographs of Gregg children. Finally, there is miscellaneous printed matter, some related to the towns of Milford and Nashua, New Hampshire.

There is no correspondence and no information about his wife, children, or other family members in this collection.

Arrangement:

The Charles H. Burns Papers are arranged by type in the following order: commonplace books,

diaries, financial records, legal records, writings, scrapbooks, photograph albums, and miscellaneous material.
