Abstract:

The Noyes Family Papers, 1893-1966, 1981-1989, contain papers of the Noyes family of Enfield, NH. The papers include certificates, report cards, military records, photographs, correspondence, and other miscellaneous documents. Family members represented in this collection include Paul Haven Noyes, Rosella Mae (Beede) Noyes, and Paul Haven Noyes Jr. Paul Haven Noyes served in the United States Navy during World War II.

Collection Overview

Biographical Information:

Carribell B. Daniels was born on September 30, 1893 in Landaff, NH, to Alfred Daniels and Carrie B. Philipps. She married Charles Leonard Beede, as his second wife, on April 28, 1915 at Hartford, VT. He was born about 1881 at Penacook, NH, son of George and Rosella (Collins) Beede. Their daughter, Rosella Mae Beede, was born on February 7, 1921 in Enfield, NH. Rosella attended public school, graduating from Enfield High School on June 14, 1939. Charles died at Enfield on June 28, 1933.

Paul Haven Noyes was born on July 10, 1920 in Laconia, NH, to Seymour J. Noyes and Lillian M. Ainsworth. A truck driver with the New Hampshire Highway Department, he served in the United States Navy during World War II, stationed in Seattle and Alaska. He enlisted on September 30, 1942 and was honorably discharged on December 22, 1945. Noyes married Rosella Mae Beede on July 5, 1946 in Enfield, NH. Together they had a son, Paul Haven Noyes Jr., on February 1, 1947 in Enfield, NH. Paul Haven Noyes died on November 6, 1998.

Collection Scope and Content Note:

The Noyes Family Papers, 1893-1966, 1981-1989, contain the papers of the Noyes family of Enfield, NH. The papers include correspondence, membership certificates, report cards and diplomas, Paul Haven Noyes' World War II United States Navy military records and Bible, New Hampshire postcards, and a few financial papers. Other materials include a number of original and official copies of family vital records (birth, marriage, death, and baptism certificates), an autograph book, *The Story of a Saucy Squirrel* by Allan Wright, and an unidentified journal containing plays, poetry, and recipes.

The correspondence consists of family letters, letters from Paul Noyes to Rosella during his military service, official military letters, and several letters regarding a song written by Rosella Noyes with sheet music included. This collection also contains a few family photographs and two folders of World War II photographs. These include images of soldiers, military events, bases, planes, and images of the battlefield. The majority of the photographs are undated and unidentified.

Family members represented in this collection include Carrie B. (Daniels) Beede, Paul Haven Noyes, Rosella Mae (Beede) Noyes, and Paul Haven Noyes II.
