Abstract:

Montgomery Rollins (1867-1918) purchased a farm in Rollinsford, New Hampshire, in 1900 and for the next 15 years wrote about it, activities there, and vignettes of and stories about inhabitants of the area. He named it "Tidewater Farm" and it was a nostalgic return to original seat of the prominent New Hampshire family, though he lived and worked primarily in the Boston, Massachusetts, area. In addition, an undated autobiographical section describes the family home in Concord, New Hampshire, and the landscape and people on a former plantation owned by the Rollins family on Fort George Island, Florida.

Collection Overview

Biographical Information:

Montgomery Rollins (1867-1918) was born in Concord, New Hampshire. His parents were Edward Henry (1824-1889) Ellen Elizabeth (West) Rollins (1826-1893). Montgomery's father served as U.S. Senator from 1877 to 1883, and Montgomery's brother Frank (1860-1915) as Governor of New Hampshire from 1899 to 1901. Montgomery, the youngest child by seven years, did not enter law or politics, but instead attended the Massachusetts Institute of Technology (1885-1888) and became a banker in the family firm, E.H. Rollins and Sons. He worked in various offices before becoming a director of the main Boston Branch in 1890. He wrote a number of books about banking and money management, including reference books and handbooks on the subject. In addition, he wrote two works of fiction, *The Village Pest: A Story of David* (1917) and *The Banker and the Boarding House* (1918).

Montgomery Rollins and Grace Webster Peavey were married on October 28, 1891 in Dover, NH. Grace was the daughter of James Frank and Sarah K. (Webster) Peavey, born on November

25, 1867 at Dover. Montgomery and Grace had two daughters, Ellen West on July 13, 1895 and Sarah Webster on June 8, 1903, both at Brookline, MA. They lived in the Boston area and, after 1900, summered at Tidewater Farm in Rollinsford, NH. Montgomery died on April 18, 1918 at Newton, MA, and was buried in Rollinsford. Grace died on July 27, 1951 at Dover and is buried with Montgomery.

Collection Scope and Content Note:

The Montgomery Rollins Diaries about Tidewater Farm in Rollinsford, New Hampshire, were kept between 1900 and 1915. There are also additional, undated sketches about the same topic with titles such as "The Tribulations of Housekeeping." All pages are typed, and some have been lightly edited, perhaps intending eventual publication. Entries, usually made from spring to fall (as the family's primary residence was in the Boston area) describe activities on the farm and include character studies of local inhabitants and anecdotes about local happenings. Most people so described are named. Rollins provides background about Rollinsford and his family's history there – though Tidewater Farm was not itself the 'old homestead' (which was sold in 1889 upon his father's death), it was across the street from it.

Other materials seem to have similar subject matter, but are titled short sketches, perhaps excerpted from the larger diaries or written separately to be published.

An undated, untitled autobiographical section [Box 2, folder 8], in addition to descriptions of the family home in Concord, New Hampshire, contains an extensive description of visits to a family property on Fort George Island, Florida, starting in the 1870s. It appears to have been written in retrospect and includes undated (but probably late 1800s to early 1900s) photographs of the property and the people living on it. This piece has descriptions of structures, landscape, and people, including the African American residents, some of them formerly enslaved. The property was owned originally by someone referred to as "Mr. Kingsley" and stories about this man's precivil war management of the plantation are recounted.

Although Montgomery Rollins was the son of U.S. Senator Edward H. Rollins and brother of Governor of New Hampshire Frank Rollins, their political lives and concerns are not mentioned in the diaries. Memories of extended family members and recollections of events, however, are nostalgically recalled.

Arrangement:

The "Diary of Tidewater Farm" is arranged chronologically, though it has been removed from the binders in which it was found. Entries are dated and most, but not all pages numbered.

Following the Tidewater Farm Diary, Rollins' other writings are in alphabetical order by title. They are undated.
