Collection Overview

Administrative Information:

In preparation for the centennial of the Weeks Act, a group of individuals came together in order to create awareness of the upcoming centennial. They helped to plan and hold events during the centennial year and created projects to ensure that the memory of the Weeks Act would live on.

The donor of this collection, who was also a member of the group, was Rebecca Weeks Sherrill More, Ph.D. Rebecca Weeks Sherrill More is the great-granddaughter of John Wingate Weeks, a Republican politician from Massachusetts and New Hampshire. The Weeks Act of 1911 is named after him. The Weeks Act is a federal law that allows for federal funding to purchase land for conservation. It used \$9 million to purchase 6 million acres of land across the eastern United States, including the White Mountain National Forest, which was established in 1918.

Rebecca Weeks Sherrill More earned a B.A. in History from the University of Virginia and holds an M.A. and Ph.D. in history from Brown University. She directed the Harriet W. Sheridan

Center for Teaching and Learning, Brown's professional development center for faculty and graduate students, until her retirement in 2010. She also taught gender and social history at the Division of Liberal Arts, Rhode Island School of Design. She continues an active research agenda, teaches and lectures, and is actively involved with environmental issues in New Hampshire. Dr. More's publications include *The Rewards of Virtue: Gentility in Early Modern England* (1998), "The Settlement Maps of Early Lancaster New Hampshire: from Colonial Plantation to Republican Township" in *Beyond the Notches: Stories of Place in New Hampshire 's North Country* (2011), along with many other articles on the history of New Hampshire. From 2010 to 2018, she researched cultural landscapes in Northern New Hampshire as a Section 106 consultant on the Northern Pass LLC Transmission Project. She serves as a trustee on a number of boards, including at the New Hampshire Historical Society. She continues active research on the social, economic, and cultural history of Early Modern England and New England.

Collection Scope and Content Note:

The Weeks Act Centennial Collection, 2009-2013, is made up of different materials related to the various centennial celebrations of the Weeks Act. Materials include promotional items for events that happened at Plymouth State University, newspaper clippings, and special issues of magazines about the Weeks Act. There is also correspondence from politicians including Jeanne Shaheen, Kelly Ayotte, Charles Bass, and Frank Guinta; their letters can be found in the "Society for the Protection of NH Forests" folder. There is also a letter from President Barack Obama. His letter can be found in the "Federal government acknowledgement" folder.

There are also several speeches and papers written by the donor Rebecca Weeks Sherrill More, Ph.D., which she presented from 2009 to 2011. These include such lectures as "The Weeks Act of 1911: The Impact of Collaboration & Compromise," "The Weeks Act of 1911: The Collaboration of Art & Politics," and "The Weeks Act of 1911: Leadership, Community & Collaboration." Also included are two DVDs produced upon the occasion.
