Abstract:

The Marshall P. Woods Papers consist of letters Woods wrote to his wife while serving in the 9th New Hampshire Regiment in the Civil War between 1862 and 1865, and two undated photographs.

The Marshall P. Wood Papers were purchased by the New Hampshire Historical Society from Raynors' Historical Collectible Auctions in six lots between 2011 and 2013.

Accession 2011.083 consists of 14 letters and was purchased in September 2011.

Accession 2011.109 consists of 21 letters and was purchased in December 2011.

Accession 2012.014 consists of 20 letters and was purchased in February 2012.

Accession 2012.032 consists of 23 letters and was purchased in 2012.

Accession 2013.006 consists of 6 letters and was purchased in January 2013.

Accession 2013.025 consists of 13 letters and 2 photographs and was purchased in April 2013.

All accession numbers have been interfiled into the 2011.083 collection.

Collection Overview

Biographical Information:

Marshall Plummer Wood (1838-1912) was the only son among the seven children of a farmer, Addison Wood (1806-1886) and Ann Plummer Wood (1809-1845) of Rindge, New Hampshire. In Rindge on October 23, 1861, Marshall married Julia A. Hunt (1839-1919), the daughter of Joshua and Lucinda (Todd) Hunt, born on July 1, 1839 at Acton, Massachusetts. Soon after the

marriage, Marshall enlisted in the 9th New Hampshire Infantry Regiment for service in the Civil War. He endured several major battles (Antietam, Fredericksburg, Petersburg, and Vicksburg among others) and was mustered out with the regiment at the end of the war. When he returned to New Hampshire, he first farmed land adjacent to his father, but eventually moved to Ashburnham, Massachusetts, where he lived until his death. He and Julia had one child, Willie Marshall Wood, who died in 1884 at the age of 16. Marshall died at Ashburnham on August 31, 1912. Julia died there on June 29, 1919.

Collection Scope and Content Note:

This collection consists of letters Marshall P. Wood (1838-1912) wrote to his wife throughout his Civil War Service. They are long and descriptive, and talk about the food, marches, living quarters, items he has bought and sold. He names other soldiers from the Rindge area he is serving with or has met, and sends messages to friends and relatives. Although never wounded, he had several close calls and was hospitalized for several months with intestinal problems.

The correspondence is exclusively outgoing, from Marshall to his wife. The collection also includes a cabinet card portrait photograph of each them taken long after the war.

Arrangement:

The letters are arranged chronologically. Envelopes are behind their letters, but not all letters have envelopes and some envelopes have no letters. Eventually, Wood began to number the envelopes, but he didn't number the letters themselves (they are always completely dated, however).
